In accordance with rule 9 of its rules of procedure, the Committee may revise the agenda during the session and may, as appropriate, defer or delete items; only urgent and important items may be added to the agenda.

#### 2. Organizational and other matters

The sixtieth session of the Committee will be held at the United Nations Office at Geneva, in Palais Wilson, from 18 April to 12 May 2017, and will be opened
