1. Adoption of the agenda

In accordance with rule 9 of its rules of procedure, the Committee may revise the agenda during the session and may, as appropriate, defer or delete items; only urgent and important items may be added to the agenda.

2. Organizational and other matters

The fifty-ninth session of the Committee will be held at the United Nations Office at Geneva, in Palais Wilson, from 7 November to 7 December 2016, and will be opened by a representative of the Secretary-General. The first meeting will be convened on Monday, 7 November 2016, at 10 a.m.
