Adoption of the report of the Committee on its fifty-third session (CEDAW/C/CHL/CO/5-6,CEDAW/C/COM/CO/1-4, CEDAW/C/GNQ/CO/6, CEDAW/C/TGO/CO/6-7 and CEDAW/C/TKM/CO/3-4; CEDAW/C/2012/III/CRP.1)

1. **Ms. Awori** (Rapporteur) introduced the Committee's draft report, which was contained in document CEDAW/C/2012/III/CRP.1. She drew attention to chapters I to IV of the draft report. Chapter IV concerned the draft concluding observations on the five reports by States parties that the Committee had considered during its fifty-third session, which were contained in documents CEDAW/C/CHL/CO/5-6, CEDAW/C/COM/CO/1-4, CEDAW/C/GNQ/CO/6, CEDAW/C/TGO/CO/6-7 and CEDAW/C/TKM/CO/3-4.

2. **The Chairperson** said she took it that the Committee wished to adopt those chapters of the draft report, as well as the documents containing the draft concluding observations.

4. **Ms. Awori** (Rapporteur) introduced the draft report of the Working Group of the Whole, contained in chapters VI and VII of the draft report, which described the actions taken by the Committee under items 6 and 7 of the agenda.

5. **The Chairperson** said she took it that the Committee wished to adopt the draft report of the Working Group of the Whole.
