Legislative framework and definition of discrimination against women

1. Please indicate whether the Convention takes precedence over national legislation in the light of the preamble to the 2011 Constitution and describe measures taken to harmonize national legislation accordingly (CEDAW/C/MAR/5-6, para. 6). Please provide information on progress made in adopting comprehensive gender equality legislation (CEDAW/C/MAR/CO/4, para. 11), as well as a definition of direct and indirect discrimination against women in the public and private spheres, including intersecting forms of discrimination, that is in accordance with articles 1 and 2 of the Convention. Please inform the Committee about steps taken to repeal provisions and practices attributing less value to women's testimony compared with that of men.

Withdrawal of reservations and ratification of the Optional Protocol

Access to justice

Impact of the pandemic on women's rights and gender equality

In line with the Committee's guidance note on the Convention on the Elimination of All Forms of Discrimination against Women and coronavirus disease (COVID-19) issued on 22 April 2020, please indicate measures implemented by the State party in the context of the COVID-19 pandemic to redress long-standing inequalities between women and men by placing women at the centre of the recovery as an economic diversification strategy; to meet the needs and uphold the rights of women and girls, including those belonging to disadvantaged and marginalized groups and women in conflict or other humanitarian situations; and to ensure that lockdown measures, whether partial or total, and post-crisis recovery plans do not see women and girls relegated to stereotyped gender roles. - (d) The impact of the implementation of the national strategy to combat violence against women.
- 10. Please indicate whether acts of gender-based violence against women are subject to ex officio prosecution, including in cases of withdrawal of the complaint or the absence of testimony by the victim in court, and how the non-prosecution of the victim and confidentiality of the proceedings are ensured. - (c) Gender bias, discriminatory stereotypes, patriarchal attitudes and victimblaming beliefs among the judiciary, police officers, religious and traditional leaders, teachers and health professionals are eliminated, and that those people are made aware of the specific risks and protection needs of women heads of household, women and girls who are domestic workers, migrant women and girls, and women and girls with disabilities.

Please provide information on support services, shelters, medical and legal assistance, psychosocial assistance and reparations available to victims of gender-based violence against women and the levels of funding of victim support services from the State budget, in particular in rural and remote areas.

Trafficking and exploitation of prostitution
