

ADOPTION OF THE REPORT OF THE COMMITTEE ON ITS TWENTY-SIXTH SESSION (CRC/C/103)

- 3. <u>The CHAIRPERSON</u> invited the Rapporteur to present section B of chapter II, entitled "Consideration of reports submitted by the States parties under article 44 of the Convention" and containing the Committee's concluding observations on the reports of Latvia, Liechtenstein, Ethiopia, Egypt, Lithuania, Lesotho, Saudi Arabia, Palau and the Dominican Republic.
- 4. <u>Mr. DOEK</u> (Rapporteur) outlined the concluding observations of the Committee on each of the reports.
