1. <u>The CHAIRPERSON</u> invited the Committee to adopt its concluding observations concerning the initial and second periodic reports of States parties considered at its twentieth session.

2. The concluding observations concerning the initial report of Austria were adopted.

Initial report of Belize (CRC/C/3/Add.46)

3. The concluding observations concerning the initial report of Belize were adopted.

Initial report of Guinea (CRC/C/3/Add.48)

4. The concluding observations concerning the initial report of Guinea were adopted.

Second periodic report of Sweden (CRC/C/65/Add.3)

5. The concluding observations concerning the second periodic report of Sweden were adopted.

Second periodic report of Yemen (CRC/C/70/Add.1)

6. The concluding observations concerning the second periodic report of Yemen were adopted.

DRAFT PROVISIONAL AGENDA FOR THE TWENTY-FIRST SESSION (CRC/C/84, chap. IV)

7. The draft provisional agenda for the twenty-first session was adopted.

ADOPTION OF THE REPORT OF THE COMMITTEE ON ITS TWENTIETH SESSION (CRC/C/84)

8. The CHAIRPERSON, introducing the draft report of the Committee on its twentieth session (CRC/C/84), briefly reviewed the main chapters: organizational and other matters, reports by States parties under article 44 of the Convention and overview of the other activities of the Committee. In that latter chapter, emphasis was placed on cooperation with United Nations and other competent bodies, the question of the draft optional protocol to the Convention on the Rights of the Child on the involvement of children in armed conflicts, the question of the draft optional protocol to the Convention on the Rights of the Child on the prevention of the sale of children, child prostitution and child pornography and the future thematic debate on the occasion of the tenth anniversary of the Convention, entitled "The Convention on the Rights of the Child: a decade of achievements and challenges". If

there was no objection, she would take it that the Committee wished to adopt the draft report on its twentieth session as a whole.
